#### A1. Basic of Preparation

The interim financial statements are unaudited and have been prepared in accordance with the applicable disclosure provisions of the Main Market Listing Requirements of Bursa Malaysia Securities Berhad and Malaysian Financial Reporting Standards ("MFRS") 134, Interim Financial Reporting in Malaysia. They do not include all of the information required for full annual financial statements, and should be read in conjunction with the audited consolidated financial statements of Yokohama Industries Berhad and its subsidiaries ("the Group") as at and for the year ended 31 December 2012.

#### A3. Auditors' Report

The auditors' report on the Group's preceding annual financial statements was not qualified.

During the quarter, the business of the Group had not been affected by any significant seasonal or cyclical factors.

There were no unusual items that have a material effect on the assets, liabilities, equity, net income or cash flow for the period.

## **A6.** Material Changes in Estimates

There were no material changes in estimates of amounts reported in prior financial year.

## A7. Debt and Equity Securities

During the quarter, the Company repurchased 389,900 of its own shares from the open market. The shares repurchased are being held as treasury shares and carried at cost. As at 31 December 2013, the total cumulative number of shares repurchased was 1,430,400 at a total cost of RM1.8 million.

Save as mentioned above, there were no issuances, cancellations, resale and repayment of debt and equity securities during the quarter.

#### A8. Dividend Paid

No dividends were paid during the quarter ended 31 December 2013.

The Directors propose a single tier final dividend of 3.70 sen per ordinary share amounting to RM 3.2 million in respect of the financial year ended 31 December 2013 for the shareholders' approval at the forthcoming Annual General Meeting. The final dividends will be recognised in the subsequent financial year upon approval by the shareholders.

## **Batteries**

Revenue and profit before tax for batteries segment were lower than that recorded in the same quarter of 2012.

This was mainly attributable to a change in sales mix and lower sales volume due to sluggish market. The effect was partly mitigated by higher selling prices during the quarter.

## **Reclamation**

Lower sales tonnage and higher scrap costs were the main drivers to the decline in reclamation revenue and profit before tax for the quarter.

The decline was mitigated by favourable exchange rates enjoyed by the segment.

## **Others**

The increase in revenue and reduction in losses recorded for the segment were mainly attributable to higher volume of charging services rendered.

## **Reclamation**

The reclamation segment registered growth in revenue and profit before tax for the year.

Higher selling prices, increase in output, better yield and favourable exchange rates were the main contributors to the growth.

Increase in sales of industrial batteries and battery related equipment and charging services have resulted in higher revenue and lower losses recorded for the segment.
