Investment in equity securities

Prior to the adoption of FRS 139, investments in non-current equity securities, other than investments in subsidiaries, were stated at cost less allowance for diminution in value which is other than temporary. With the adoption of FRS 139, quoted investments in non-current equity securities, other than investments in subsidiaries, are now categorized and measured as fair value through profit or loss, or as available-for-sale investments.

Derivatives

Prior to the adoption of FRS 139, derivative contracts were recognized in the financial statements on settlement date. With the adoption of FRS 139, derivative contracts are now categorized as fair value through profit or loss and measured at their fair value with the gain or loss recognized in the profit or loss.

❖ Impairment of trade and other receivables

Prior to the adoption of FRS 139, an allowance for doubtful debts was made when a receivable is considered irrecoverable by the management. With the adoption of FRS 139, an impairment loss is recognized for trade and other receivables and is measured as the difference between the asset's carrying amount and the present value of estimated future cash flows discounted at the asset's original effective interest rate.

The Group faces minor seasonal fluctuations during the major festive seasons such as Hari Raya Aidilfitri and Chinese New Year celebrations.

B1 Review of performance of the company and its principal subsidiaries for the current quarter and financial year to date (YTD)

Group revenue for the current quarter was RM137.5 million, increased by 43.1% over the same quarter last year. Profit before taxation for the quarter under review also soared substantially from RM9.9 million losses last year to RM9.7 million profit this quarter. Uptrend in the steel prices and market demand experienced since the later part of last year coupled with improvement in business conditions amidst robust domestic economy growth were the keys to the overall improvements.

B2 Material changes in the profit before taxation for the quarter reported on as compared with the immediate preceding quarter

Group revenue for the current guarter was 3.3% higher than the immediate preceding quarter's RM133.1 million. Profit before tax also surged by 24.9% over the immediate preceding quarter's RM7.8 million. The improvement in the profit before tax for the quarter reported was mainly due to the better sales margin as a result of rising steel prices amidst better market demand as well as on-going costs reduction exercise and operational efficiencies improvement program.

B3 Prospects

In line with the continued uptrend in steel material prices, albeit some volatility foreseen, coupled with robust growth in domestic economy and sustained market demand, the Board is of the opinion that the performance of the Group for the rest of the year will continue to be satisfactory.
