The Group recorded a 2.05% decrease in the turnover to RM 31.32 million for the second quarter ended 30 June 2011 from RM 31.97 million in the corresponding quarter last year. The marginal decrease in turnover was mainly due to the lower demand in domestic market in the current quarter.

The loss before tax decreased by RM 0.23 million for the second quarter ended 30 June 2011 to RM 0.47 million as compared to the corresponding quarter last year, this was mainly due to the lower selling costs incurred in the current quarter.

In the opinion of the Directors, the results of the current quarter under review have not been substantially affected by any item, transaction or event of a material and unusual nature.
