The Group recorded a 7.9% decrease in revenue to RM 32.81 million for the first quarter ended 30 September 2018 from RM 35.61 million in the corresponding quarter last year. The Group recorded a 14.6% increase in revenue to RM 32.81 million for the first quarter ended 30 September 2018 from RM 28.65 million in the preceding quarter. The increase in turnover was mainly due to the improved sales performance from the local subsidiaries in the current quarter under review.

For the current quarter under review, the Group recorded a loss before tax of RM1.86 million as compared to a loss before tax of RM 13.32 million generated in the preceding quarter. The lower loss was mainly due to no allowance for inventory written off and impairment loss on trade and other receivables in the current quarter as well as lower machinery maintenance cost and replacement parts.
